- Enrichment Programs courses will only receive .125 credit per course/semester, as they are a supplemental program in conjunction with homeschooling.
- English/Composition credit is given as a whole component. For example, spelling, grammar, writing/reading, would not be awarded as separate credits.
- Literature credit is given for courses that examine and emphasize the criteria, relationships, and techniques of oral and written genres. Courses must emphasize active and responsive reading (fiction, poetry, nonfiction, drama).
- Only classes taken in 9th - 12th grade will receive high school credit, regardless of the the course content.
- Courses are only added to the high school transcript if the student is a full-time CEC student.
- The school of record will be notated on the CEC transcript as "Homeschool" for courses listed on the homeschool transcript.
- Transcripts are considered a complete document. Students/parents/guardians may not request that some previous courses be transferred, and others not transferred. However, CEC Registrars may elect to exclude certain courses from a transcript.
- CEC will only add courses to the transcript that correspond to the student's grade level upon entering CEC, based on the following chart. Exceptions are made only for 5th year seniors to have four previous years included.

Grade entering CEC	Previous grades to include on transcript
10 th	9 th
11 th	9 th - 10 th
12 th	9 th - 11 th

- Credit for course work done prior to the student's 9th grade year will only be reflected on the transcript if it meets the requirements on the "CEC Guidance for Granting Credit for High School Coursework Taken in Middle School Policy Document."
- Part-time student transcripts with previous courses from other institutions will not be posted to CEC's transcript.

- Part-time students approved to go to full-time status will have 30 days from the date of the approval to submit their final transcript. Changes made to the original transcript submitted at the time of enrollment will NOT be accepted. All transcripts should be sent to the attention of the CECFC Registrar at this email address - CECFCTSInquires@coloradoearlycolleges.org. Full-time/Part-time status changes can occur only once during the student's enrollment at CEC and must be approved by the student's advisor.
- Course credit is granted from the original transcript submitted. Changes made to the original transcript submitted at the time of enrollment will NOT be accepted
- Each semester credit (.5) represents at least 60 hours of student work or at least 50% completion of a typical textbook.
- Each full year credit (1) reflects at least 120 hours of student work or at least 90% completion of a typical textbook.
- Transferred courses, are generally awarded .5 credit per semester. On average, students will be granted 5-7 credits per year
- Credit will only be granted from homeschool transcripts that are signed and dated by a parent/guardian.
- Only courses that were completed through a homeschool curriculum should be included on the [CEC Homeschool Transcript](#). Credit for courses taken through public institutions (i.e., Options, online programs, colleges, etc.) will only be granted from official transcripts received directly from them.
- Students that enter CEC as full-time students are no longer considered homeschooled and must abide by all CEC policies and procedures, including state testing and [graduation requirements](#).
- Students must have full-time status for at least one semester to be eligible for CEC graduation
